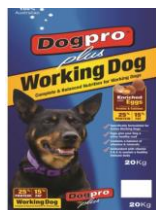

## **BASIC TRIAL RULES**

1. Each worker has 15mins to complete the course of 4 obstacles.

The run ends when –

the time is up

or all sheep are in the pen with the gate closed

or the dog goes between the worker and the sheep

(i.e. Crosses )

There is no advantage in completing the course in a shorter time than other workers.

2. Each worker starts with 100 points and points are lost for sheep being off course, running around obstacles or for any obstacles that are not completed.

3. Three fresh sheep are used for each run. The sheep are only used once and have not seen the obstacles before,  
*Some sheep are more cooperative than others !!!*

4. The trial judge ( who is walking around the field) awards each competitor their score. The judge also has the authority to disqualify a worker if the welfare of the dog or sheep becomes a concern.

5. The worker is not allowed to influence the sheep in any way and may only instruct their dog by either voice or whistle commands. This is because the trial is to judge the ability of the dog to handle the sheep.
