Venue: Victoria Park, High Street Koroit, Victoria

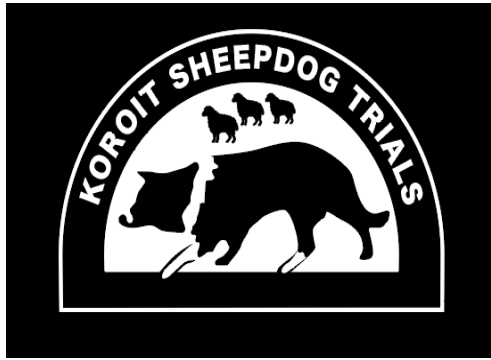
Accommodation: Camping is available at Victoria Park for **\$10 per night**.
