GENERAL REGULATIONS:

1. All competitors enter at their own risk
2. Name, Registration number and Entry fees must accompany entry. Dogs to be entered and numbered in order they are to run.
3. In the event of excessive entries workers may be limited to the number of dogs accepted.
4. **WORKERS ENTERING ONE OR TWO DOGS.** If you have entered **ONLY 1 dog** at the Trials (and no other dogs) you may indicate to work in the last round of the trial/s entered. If you have entered **ONLY 2 dogs** you have the option of having your dogs placed in the last 2 rounds OR the first 2 rounds of the draw of the Novice/Encourage AND/OR Improvers/Open. You may enter one of the two dogs and indicate to be drawn in the first OR last round. This must be clearly stated on the entry form. These are the only runs allowed at the Trials (except for finals) and no other dogs can be entered. If you do not indicate you are entering one or two dogs on the entry form your dogs will be drawn as normal (ie in first round or first 2 rounds)
5. Farmers & Encourage Trials eligibility
 - (a) Farmers Trial -
 - (b) Encourage Trial

Eligibility:

For workers who have not won a Novice or higher trial

A worker can only win two Farmers trials

A worker can only win two Encourage trials

Limited to one Improver/Open Dog per worker.

Note: Workers may win two Farmers and two Encourage trials in any order before becoming ineligible to compete in either Farmers and/or Encourage.

6. Encourage and Farmers Trials Workers must be:

- a full member of VWSDA Inc **OR**

If not a Full Member or Associate Member entries may be made by Event Membership for Encourage and Farmers Trial. Please enclose \$20 and an event membership form will be forwarded to you with the draw to complete and return.

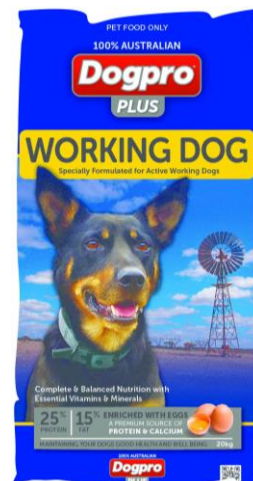
7. **CAMPING:** \$27.50 per day for caravan/camping fees. Please include with entries
8. **CATERING:** Two course lunch + morning/afternoon tea available each day in Ken Hall Pavilion
 - BBQ for Triallers, sponsors, officials and volunteers at approximately 6.30 pm on Friday evening
9. All scratchings prior to trials **AND ON THE DAY** to be advised **TO THE SECRETARY**, NOT TIMEKEEPERS
10. Order of Judging – one competition arena will operate. Subject to entries, Judging is planned to commence at 8.00 am on Friday 27th March commencing with Improvers/Open until lunch time with Novice commencing at lunch time. The Encourage will run at the end of the Novice draw. Depending on entries, finals (Open, Improver and Novice) will be held on Saturday afternoon and/or Sunday. No finals for Encourage and Farmers. The Farmers Trial will be judged on Sunday 28th March (depending on entries).
11. All dog poo to be picked up on the venue.
12. Entries by Event Membership eligible for Encourage and Farmers Trial
13. **ENTRIES:** To ensure entries are received by the close of entries –, please post via **EXPRESS POST**.
